A palletized load shall not exceed 4,000 pounds and should not exceed 52 inches in length or width, or 54 inches in height. The load shall be contained in a manner that will permit safe handling during shipment and storage.

c. REALISM ASK, "DOES THE PROPOSAL PRICE ACCURATELY REFLECT THE OFFEROR'S PROPOSED EFFORT TO MEET THE PROGRAM REQUIREMENTS AND OBJECTIVES." AN UNREASONABLE OR UNAFFORDABLE PRICE MAY PRECLUDE AN OFFEROR FROM AWARD. THE GOVERNMENT RETAINS THE RIGHT TO OBTAIN ADDITIONAL COST/PRICE DATA, FROM ANY OFFEROR IN THE EVENT OF A LACK OF COMPETITIVE BIDS.
3. IF THE OFFEROR FAILS TO PROPOSE FOR ALL PRICING PERIODS OR RANGES, THE GOVERNMENT MAY REJECT THAT OFFER AS UNACCEPTABLE.
