This is the guaranteed minimum quantity to be awarded under this solicitation and specifically represents the guaranteed "minimum" quantity as defined by the referenced FAR and DFARS clauses contained within this solicitation document either in full text or incorporated by reference. The guaranteed minimum quantity will be obligated at time of award under Delivery Order 0001. All other estimated buy quantities are estimates only, and do not bind the Government in any way.

4. Ordering periods covered by this solicitation are specified below. The additional two years which may be exercised by the Government are optional years. The Government, at its sole discretion, may exercise these optional years provided that written notice is provided to the contractor 30 days before expiration of Ordering Period 3. Both optional years expire if the Government does not exercise its option for the 4th year period. The Government is not obligated to extend the term of the contract beyond the initial three-year period.

Ordering Period 1: Date of award - 31 August 2004
Ordering Period 2: 1 September 2004 - 31 August 2005
Ordering Period 3: 1 September 2005 - 31 August 2006
Optional Period 1: 1 September 2006 - 31 August 2007

5. The Government's projected buy quantities, by Ordering Period, as set forth on the Pricing Evaluation Sheet (Attachment 002) represent the best estimate of actual projected demands. These quantities may be impacted by many unforeseen factors including changing technologies and budgetary influences, etc. The minimum and maximum quantity pricing ranges are provided solely for the purpose of establishing reasonable ranges of quantities against which to provide prices, and to establish ordering limitations in the event that orders beyond the minimum quantities are executed. The Pricing Evaluation Sheet also establishes the ordering limitations defined in Clause IF6029, "Order Limitations" (FAR 52.216-19). Under this IDIQ contract scenario, the Government promises a minimum buy quantity at time of contract award. Except for the guaranteed minimum quantity stated above, the Government does not guarantee any future awards of projected buys.

6. The proposed unit prices for all quantities, both the guaranteed minimum quantity and the indefinite quantities shall be marked on the Pricing Evaluation Sheet at Attachment 002. Proposals failing to offer prices for all five pricing periods will not be considered. Proposals offering prices for quantities other than those solicited will not be considered.

7. All delivery orders will be issued UNILATERALLY by the Government with firm delivery dates at the unit price corresponding to the ordering period. The delivery date for all delivery orders will be 150 days after award.

8. Offerors are required to submit prices for production deliveries based on F.O.B. Destination. 2. Unit package. A unit package shall be so designed and constructed that it will contain the contents with no damage to the item(s), and with minimal damage to the unit pack during shipment and storage in the shipping container, and will allow subsequent handling.
