This is the guaranteed minimum quantities to be awarded under this solicitation and specifically represents the guaranteed "minimum" quantities as defined by the referenced FAR and DFARS clauses contained within this solicitation document either in full text or incorporated by reference. 5. The Government's projected buy quantities, by Ordering Period, as set forth on the Price Evaluation Sheet (Attachment 4) represent the best estimate of actual projected demands. The Government has weighted the ranges based on the likelihood that if an order is placed, it will be placed in that range. These quantities may be impacted by many unforeseen factors including changing technologies and budgetary influences, etc. The minimum and maximum quantity pricing ranges are provided solely for the purpose of establishing reasonable ranges of quantities against which to provide prices, and to establish ordering limitations in the event that orders beyond the minimum quantities are executed. The Price Evaluation Sheet also establishes the ordering limitations defined in Clause IF6029, "Order Limitations" (FAR 52.216-19). Under this IDIQ contract scenario, the Government promises minimum buy quantities at time of contract award. Except for the guaranteed minimum quantities stated above, the Government does not guarantee any future awards of projected buys.

6. The proposed unit prices for all quantities, both the guaranteed minimum quantities and the indefinite quantities shall be marked on the Price Evaluation Sheet at Attachment 4. Proposals failing to offer prices for all three pricing periods will not be considered. Proposals offering prices for quantities other than those solicited will not be considered. Offerors are not required to price both CLINs (Contract Line Item Number) in order to be considered. The Government reserves the right to award each CLIN separately.

7. All delivery orders will be issued UNILATERALLY by the Government with firm delivery dates at the unit price corresponding to the ordering period. The delivery date for all delivery orders will be 150 days after award.

8. Offerors are required to submit prices for production deliveries based on F.O.B. Destination. 1.3 Cushioning - Items requiring protection from physical and mechanical damage (e.g., fragile, sensitive, material critical) or which could cause physical damage to other items, shall be protected by wrapping, cushioning, pack compartmentalization, or other means to mitigate shock and vibration to prevent damage during handling and shipment.

2 Unit Package. A unit package shall be so designed and constructed that it will contain the contents with no damage to the item(s), and with minimal damage to the unit pack during shipment and storage in the shipping container, and will allow subsequent handling. The outermost component of a unit package shall be a container such as a sealed bag, carton or box.

3 Unit Package Quantity. Unless otherwise specified, the unit package quantity shall be one each part, set, assembly, kit, etc.

4 Intermediate Package - Intermediate packaging is required whenever one or more of the following conditions exists:

- the quantity is over one (1) gross of the same national stock number,
- use enhances handling and inventorying,
- the exterior surfaces of the unit pack is a bag of any type, regardless of size,
- the unit pack is less than 64 cubic inches,
- the weight of the unit pack is under five (5) pounds and no dimension is over twelve (12) inches.

Intermediate containers shall be limited to a maximum of 100 unit packs, a net load of 40 pounds, or a maximum volume of 1.5 cubic feet, whichever occurs first.

## 5. Packing:

5.1 Unit packages and intermediate packages not meeting the requirements for a shipping container shall be packed in shipping containers. All shipping containers shall be the most cost effective and shall be of minimum cube to contain and protect the items.
