1. This solicitation is for one (1) installed Rotary Screw Air Compressor on a GFM USMC Shop Equipment Contact Maintenance Truck.
2. This requirement is for an installed Rotary Screw Air Compressor System that meets the following requirements:
 - a. The rotary screw air compressor shall provide a high temperature cut-off switch.
 - b. The envelope dimension for rotary screw air compressor alone shall not exceed 7in x 8in x 12in.
 - c. The rotary screw air compressor shall provide at least 30 SCFM at 175PSI.
 - d. The rotary screw air compressor weight shall not exceed 50 lb.
 - e. The rotary screw air compressor system shall provide automatic throttle control for the GFE SECM engine. This control will be used to match air demand.
 - f. The air receiver tank shall be incorporated in the system:
 - a. Tank size 3 US. Gallons
 - b. 200 PSI high pressure relief valve
 - c. Integrated coalescing oil separator element
 - d. Lubricant sight glass
 - e. Replaceable spin on 25 micron oil filter with safety bypass feature
 - f. 8 sec. automatic blow down valve

 - h. Weight shall not exceed 20 lb.

The Government shall furnish as a part of the contract such technical information and related to performance requirements as necessary for the contractor to perform this contract; to include a GFE SECM and all related technical publications for the SECM and the HMMWV platform on which the SECM is mounted. The contractor shall mount their proposed rotary screw compressed air system in the GFE SECM. This system shall be mounted under the hood of the GFE SECM. The contractor shall provide a complete set of installation instructions. These instructions will outline in detail all of the necessary steps needed to complete the modification of SECM and installation of the rotary screw air compressor. These instructions shall be prepared in a format of the contractor choosing using Microsoft Word and shall be provided to the government for review.

4. Product consistency is required throughout the life of the contract. The offeror's technical proposal for the installed rotary screw air compressor will be incorporated into the award document. Any proposed changes to the proposal must be approved in advance by the Government. It is anticipated that voluntary/unnecessary changes will be disapproved. You are encouraged to establish long-term agreements with your suppliers and subcontractors to insure continued availability of all components. In addition, if changes are approved, the necessary operating/maintenance updated instructions will be required.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to the Contract Disputes Act of 1978, as amended (41 U.S.C. 601-613). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference.
