(i) If Government production and research property is being used on other work under one or more existing contracts for which use has been authorized, the evaluation factor shall be determined by prorating the rent between the proposed contract and such other work. The pro-rata share applicable to a proposed contract shall be determined by multiplying the full rental charge for use of Government production and research property for the period for which rent-free use is requested by a fraction, the numerator of which is the amount of use of such property requested by the contractor under this proposed contract and the denominator of which is the sum of the previous authorized use of the property by the contractor for the period and the use requested under the proposed contract. M.1. BASIS FOR AWARD

M.1.1. The Government will make an award to that offeror whose proposal represents the best value to the Government based on an integrated assessment of price and performance risk. Performance risk is slightly more important than price.

M.1.2. Under best value, the Government reserves the right to make an award to other than the low priced offeror or to other than the offeror rated highest in the non-price factor. Although price is not the most important consideration, it could be controlling where an otherwise superior proposal is at an unaffordable or unreasonable price, where two proposals are otherwise considered equal, or where the advantages of a superior proposal are not worth the price premium.

M.1.3. Proposals which merely offer to perform the work in accordance with the request for proposal or which are so lacking in content and detail that the Government cannot conduct a meaningful evaluation without significant supplementation are unacceptable and will not be considered for award.

M.1.4. The Contracting Officer may obtain a pre-award survey to facilitate the evaluation of any offeror's proposal and may consider the findings of any such pre-award survey in the selection decision.

M.2. PRICE

M.2.1. The CLIN Evaluated Prices will be calculated by summing the multiplication of each Order Quantity Unit Price by its respective Weight and the Minimum Order Quantity of the Range for each Ordering Period. The sum of all CLIN Evaluated Prices will be the Total Evaluated Price.

M.2.2. Any proposal, which is unreasonably high or low in price, will be deemed indicative of a failure to comprehend the Governments requirements and may be rejected for such a reason.

M.3. PERFORMANCE RISK

M.3.1. The Government will conduct a performance risk assessment based on the past performance as it is related to the probability of successful accomplishment of the required effort. When assessing performance risk, the Government will focus its inquiry on the past performance of the offeror as it is related to the solicitation requirements, including quality and contract schedules.

M.3.2. The Government will focus its past performance inquiry on all aspects of contract performance, including quality of workmanship, delivery schedule conformance, and the offeror's general history of cooperative behavior and commitment toward customer satisfaction.

M.3.3. Performance Risk Ratings:

Performance risk will be adjectively/narratively assessed with a risk rating applied to each offeror as follows:

a. EXCELLENT: Essentially no doubt exists that the offeror will successfully perform the required effort based on previous performance history - Very Low Risk.

b. GOOD: Little doubt exists that the offeror will successfully perform the required effort based on previous past performance history - Low Risk.

Name of Offeror or Contractor:

- c. ADEQUATE: Some doubt exists that the offeror will successfully perform the required effort based on previous past performance history - Moderate Risk.
- d. MARGINAL: Substantial doubt exists that the offeror will successfully perform the required effort based on previous past performance history - High Risk.
- e. POOR: It is extremely doubtful that the offeror will successfully perform the required effort based upon previous past performance history/experience reviewed - Very High Risk.
- f. NEUTRAL: There is no meaningful relevant record of past performance - Unknown Risk.

M.3.3.1. Performance Risk - A significant achievement, problem, or lack of relevant data in any element of the work can become an important consideration in the source selection process. A negative finding under an element may result in an overall high performance risk rating. Therefore, offerors are reminded to include all relevant past efforts, including demonstrated corrective actions, in their proposals. The lack of meaningful relevant past performance records may result in an unknown performance risk rating.
