b. Unitization Shipments of identical items going to the same destination shall be palletized if they have a total cubic displacement of 50 cubic feet or more unless skids or other forklift handling features are included on the containers. Pallet loads must be stable, and to the greatest extent possible, provide a level top for ease of stacking. A palletized load shall not exceed 4,000 pounds and should not exceed 52 inches in length or width, or 54 inches in height. The load shall be contained in a manner that will permit safe handling during shipment and storage.

c. Marking: In addition to any special markings called out on the SPI, all unit packages, intermediate packs, exterior shipping containers, and as applicable, unitized loads shall be marked in accordance with MIL-STD-129, Revision -6-, Date -7-, including bar coding in accordance with ANSI/AIM-BC1, Uniform Symbology Specification Code 39.

d. This SPI has been validated and the method of preservation/packing has proven successful in meeting the needs of the military distribution system, including indeterminate storage and shipment throughout the world. Special instructions and/or tailoring of the SPI is detailed in the Supplemental Instructions in paragraph e below. A prototype package is required to validate the sizes and fit requirements of the SPI. Minor dimensional and size changes are acceptable provided the contractor notifies the Administrative Contracting Officer.60 days prior to delivery. Any design changes or changes in the method of preservation that provide a cost savings without degrading the method of preservation or packing or affecting the serviceability of the item will be considered and responded to within 10 days of submission to the Contracting Officer and the Administrative Contracting Officer. B. THE SURFACE SHALL BE WIPED WITH A CIRCULAR MOTION USING COTTON, LENS TISSUE PAPER OR FRESHLY LAUNDERED CHEESECLOTH WHICH IS SATURATED WITH ALCOHOL.

C. A SWAB SHALL BE MADE BY ONE PIECE OF LENS TISSUE PAPER AROUND THE END OF AN ORANGE STICK OR EQUAL. ONE OR TWO DROPS OF ALCOHOL SHALL BE ADDED ON THE TIP OF THE SWAB. THE SWABBING OPERATION SHALL BEGIN AT THE CENTER OF THE POLISHED SURFACES. A LIGHT DOWNWARD PRESSURE SHALL BE EXERTED ON THE SWAB END AND WITH A CIRCULAR MOTION GRADUALLY INCREASE THE RADIUS OF THE AREA BEING CLEANED UNTIL THE ENTIRE SURFACE HAS BEEN SWABBED. THIS OPERATION SHALL BE REPEATED UNTIL NO TRACES OF DIRT, LINT, OR SMEARS ARE PERCEPTIBLE.

D. THE SURFACE SHALL BE DRIED BY WIPING WITH CLEAN COTTON, LENS PAPER OR FRESHLY LAUNDERED CHEESECLOTH. A RUBBER SYRINGE SHALL BE USED AS BELLOWS TO REMOVE ANY RESIDUAL DUST OR LINT THAT MAY REMAIN ON THE CLEANED SURFACES.
