(8) A nondevelopmental item, if the procuring agency determines the item was developed exclusively at private expense and sold in substantial quantities, on a competitive basis, to multiple State and local Governments.

(d) Component means any item supplied to the Federal Government as part of an end item or of another component.

''Person,'' as used in this clause, means a corporation, partnership, business association of any kind, trust, joint-stock company, or individual.

''Prime contract,'' as used in this clause, means a contract or contractual action entered into by the United States for the purpose of obtaining supplies, materials, equipment, or services of any kind.

''Prime Contractor'' as used in this clause, means a person who has entered into a prime contract with the United States.

''Prime Contractor employee,'' as used in this clause, means any officer, partner, employee, or agent of a prime Contractor.

''Subcontract,'' as used in this clause, means a contract or contractual action entered into by a prime Contractor or subcontractor for the purpose of obtaining supplies, materials, equipment, or services of any kind under a prime contract.

''Subcontractor,'' as used in this clause (1) means any person, other than the prime Contractor, who offers to furnish or furnishes any supplies, materials, equipment, or services of any kind under a prime contract or a subcontract entered into in connection with such prime contract, and (2) includes any person who offers to furnish or furnishes general supplies to the prime Contractor or a higher tier subcontractor.

''Subcontractor employee,'' as used in this clause, means any officer, partner, employee, or agent of a subcontractor.

(b) The Anti-Kickback of 1986 (41 U.S.C. 51.58) (the Act), prohibits any person from--

(1) Providing or attempting to provide or offering to provide any kickback;

(2) Soliciting, accepting, or attempting to accept any kickback; or

(3) Including, directly or indirectly, the amount of any kickback in the contract price charged by a prime Contractor to the United States or in the contract price charged by a subcontractor to a prime Contractor or higher tier subcontractor.

(c)(1) The Contractor shall have in place and follow reasonable procedures designed to prevent and detect possible violations described in paragraph (b) of this clause in its own operations and direct business relationships.

(3) The Contractor shall cooperate fully with any Federal agency investigating a possible violation described in paragraph (b) of this clause.

(4) The Contracting Officer may (i) offset the amount of the kickback against any monies owed by the United States under the prime contract and/or (ii) direct that Prime Contractor withhold from sums owed a subcontractor under the prime contract the amount of the kickback. The Contracting Officer may order that monies withheld under subdivision (c)(4)(ii) of this

T: Total acquisition cost of facilities (including, if paid by the Government, cost of transportation and installation as well as any cost expended to enhance the condition of the machine).

R: Rental rate.

P: Production period (months).

Q: Quantity of items to be procured.

S: Pro rata share, if applicable.

C: Evaluation factor to be added to unit price.

(h) This evaluation procedure shall not be applicable to any item or items of Government property held by the offeror under a valid lease or rental arrangement with the Government wherein the offeror is granted right of usage of such property and must pay a rental thereon for the entire leasehold/rental period irrespective of actual usage.

(i) If Government production and research property is being used on other work under one or more existing contracts for which use has been authorized, the evaluation factor shall be determined by prorating the rent between the proposed contract and such other work. The pro-rata share applicable to a proposed contract shall be determined by multiplying the full rental charge for use of Government production and research property for the period for which rent-free use is requested by a fraction, the numerator of which is the amount of use of such property requested by the contractor under this proposed contract and the denominator of which is the sum of the previous authorized use of the property by the contractor for the period and the use requested under the proposed contract. The Contractor must indicate in its bid offer if a pro-rata share is applicable for this procurement.

(j) Special considerations relating to use of Government-owned facilities and special tooling by subcontractors.

(1) Evaluation factors applied to prime contractor's offers will be the same for both proposed prime contractor's and subcontractor's use of Government-owned property, including evaluation rates and production period.

(2) In the event that any prospective subcontractor desiring use of Government property pursuant to this provision refuses to quote a price to any prospective prime contractor or refuses to quote on an equal basis to all prospective prime contractors, the Government reserves the right to:

(i) Refuse to authorize the subcontractors use of such property, or;

(ii) Evaluate 100% of the acquisition cost (including cost of transportation, and installation, and enhancement paid by the Government) of such property against the offer of the prime contractor proposing to use such subcontractor.

PERFORMANCE RISK IS MUCH MORE IMPORTANT THAN PRICE. THE GOVERNMENT WILL EVALUATE FOUR ELEMENTS UNDER PERFORMANCE RISK: (1) TECHNICAL (2) PAST PERFORMANCE (3) QUALITY AND (4) SMALL BUSINESS UTILIZATION. OF THESE ELEMENTS, TECHNICAL IS THE MOST IMPORTANT, PAST PERFORMANCE AND QUALITY ARE EQUAL BUT LESS IMPORTANT AND SMALL BUSINESS UTILIZATION IS LEAST IMPORTANT.

B. UNDER BEST VALUE, THE GOVERNMENT RESERVES THE RIGHT TO MAKE AN AWARD TO OTHER THAN THE LOW PRICED OFFEROR OR TO OTHER THAN THE OFFEROR RATED THE HIGHEST IN THE NON-PRICE FACTOR. M.2 PERFORMANCE RISK

D. CLEAR UNDERSTANDING OF THE GOVERNMENT TECHNICAL DATA PACKAGE EVIDENCED BY WRITTEN QUOTES OBTAINED FROM ALL SOURCE CONTROL VENDORS FOR EACH PRODUCTION ITEM.

M.2.1.2 TECHNICAL RISK RATINGS: TECHNICAL RISKS ARE THOSE RISKS ASSOCIATED WITH AN OFFEROR'S LIKELIHOOD OF SUCCESS IN PERFORMING TO THE SOLICITATION'S TECHNICAL REQUIREMENTS AS INDICATED BY THAT OFFEROR'S PROPOSAL. M.2.2 PAST PERFORMANCE

M.2.2.1 A SIGNIFICANT ACHIEVEMENT, PROBLEM OR LACK OF RELEVANT INFORMATION CAN BECOME AN IMPORTANT CONSIDERATION OF THE SOURCE SELECTION PROCESS. THEREFORE, OFFERORS ARE REMINDED TO INCLUDE ALL RELEVANT PAST EFFORTS, INCLUDING DEMONSTRATED CORRECTIVE ACTIONS, IN THEIR PROPOSALS. M.2.2.2 OFFERORS ARE CAUTIONED THAT IN CONDUCTING THE PAST PERFORMANCE RISK ASSESSMENT, THE GOVERNMENT MAY USE DATA PROVIDED BY THE OFFEROR IN ITS PROPOSAL AND DATA OBTAINED FROM OUTSIDE SOURCES. M.2.2.4 PERFORMANCE RISK RATINGS: PERFORMANCE RISKS ARE THOSE RISKS ASSOCIATED WITH AN OFFEROR'S LIKELIHOOD OF SUCCESS IN PERFORMING THE SOLICITATION'S REQUIREMENTS INDICATED BY THAT OFFEROR'S RECORD OF PAST PERFORMANCE. PERFORMANCE RISK WILL BE ADJECTIVALLY/NARRATIVELY ASSESSED WITH A RISK RATING APOPLIED TO EACH OFFEROR.

M.2.3 QUALITY

THE QUALITY ELEMENT WILL BE EVALUATED BY REVIEWING THE INFORMATION FURNISHED CONCERNING THE OFFEROR'S QUALITY SYSTEM. THE GOVERNMENT WILL DETERMINE THE LIKELIHOOD OF THE OFFEROR ONLY PROVIDING CONFORMING MATERIAL FOR ACCEPTANCE. EVALUATION WILL CONSIST OF ASSESSING THE EFFECTIVENESS OF THE TOTAL QUALITY SYSTEM, INCLUDING HOW WELL THE ACCURACY/PRECISION OF ACCEPTANCE INSPECTION EQUIPMENT AND ALL OTHER PROCESSES ARE CONTROLLED. M.2.4 SMALL BUSINESS UTILIZATION

M.3 PRICE

M.3.1 FOR PURPOSES OF EVALUATING CLIN 0001 THROUGH CLIN 0003, THE PROPOSED UNIT PRICES FOR EACH QUANTITY ORDER RANGE WILL BE MULTIPLIED BY THE WEIGHT OF THE RANGE TO DETERMINE A WEIGHTED AVERAGE PRICE FOR EACH PRICING PERIOD. M.3.2 EACH CLIN WILL BE EVALUATED SEPARATELY. A TOTAL EVALUATED PRICE WILL BE DETERMINED BY ADDING THE EVALUATED CLIN PRICE AND ANY OTHER PRICE RELATED EVALUATION FACTORS REQUIRED BY THE SOLICITATION. IF AN OFFEROR FAILS TO PROPOSE FOR ALL PRICING PERIODS, THE GOVERNMENT MAY REJECT THAT OFFER AS UNACCEPTABLE.

M.3.4 THE GOVERNMENT RESERVES THE RIGHT TO MAKE MULTIPLE AWARDS IF, AFTER CONSIDERING THE ADDITIONAL ADMINISTRATIVE COSTS, IT IS IN THE GOVERNMENT'S BEST INTEREST TO DO SO.
