SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this Amendment 0006 is to implement the following corrections/clarifications:

a. Amendment 0003 deleted CLINs 0001AA through 0016 from the basic solicitation due to internal systems errors.

b. Amendment 0004 was an administrative action due to internal systems changes necessary in order to correct Section B.

2. As of 12 December 2000, the needed changes have not been made to our internal systems. Therefore, Amendment 0005 extends the closing date from 15 December 2000 to 22 December 2000, at 3:45 P.M. C.S.T.

3. All other terms and conditions remain the same.

c. The first sentence of Paragraph 5 of the basic solicitation is deleted. Offerors are NOT required to price CLIN 0001 in Section B. ALL PRICING IS TO BE INDICATED ON ATTACHMENT 003, PRICE EVALUATION SPREADSHEET. For clarification, Paragraph 5 of the basic solicitation is changed as follows:

"5. The proposed unit prices for all quantities, both the guaranteed minimum quantity and the indefinite quantities shall be marked in the table at Attachment 003. Proposals failing to offer prices for all FIVE ordering periods will not be considered. Proposals offering prices for quantities other than those solicited will not be considered."

c. The shipping destination for CLIN 0001 is New Cumberland Army Depot, PA and is incorporated in Section B of this Amendment 0004.

d. Amendment 0002 corrected the NSN for CLIN 0012, but did not correct the Part Number. The following description has been incorporated into Section B and on Attachment 003, Price Evaluation Spreadsheet:

2. For clarification purposes, Section B and Attachment 003 are printed out in full text with the corrected information.

5. All other terms and conditions remain the same.
