SECTION A - SUPPLEMENTAL INFORMATION

The purpose of this amendment is to make the following revisions to Amendment 0003 and to Attachment 0006 to the basic solicitation.

1. The second sentence of Paragraph 6 located on page 2 of Amendment 0003 is deleted and replaced with the following:

"Offerors must complete the attached pricing sheets and submit them to our office on or before April 18, 2001, 3:45 p.m., since previously submitted pricing sheets are no longer valid."

2. The sentence located after Paragraph 9c located on page 4 of Amendment 0003 is deleted and replaced with the following:

"You must acknowledge this amendment and submit the completed revised pricing spreadsheets on or before April 18, 2001, 3:45 p.m. Your acknowledgement of this amendment and your completed revised pricing spreadsheets must be signed by a person who is authorized to bind your company."

Discussions are hereby continued. During discussions, you may address any deficiencies and significant weaknesses in your offer; you may submit proposal revisions to the Government (the proposal revisions must be signed by a person who is authorized to bind your company); and you may ask the Government questions.

Upon conclusion of discussions, the Contracting Officer will request final proposal revisions from those offerors who have not been eliminated from the competitive range."

3. Attachment 0006, (entitled "Section L"), of the basic solicitation is revised as follows.

The second sentence in Paragraph L.2.1.1. Element 1, Past Performance is changed to read as follows:

"The term "similar" is defined as a contract over \$25,000 for manufacturing and assembly of vehicle seats and seat components that incorporate seat cushions using heavy-duty vinyl material with a molded pattern and the forming of the seat cover which prohibits the material from having any folds or creases."
