SUPPLEMENTAL INFORMATION

1. This solicitation DAAE20-01-T-0111 for a 4 Ton Hydraulic Floor Dolly Jack NSN: 4910-00-516-5806 and 10 Ton Hydraulic Floor Dolly Jack NSN: 4910-00-289-7233 (see attachment 002 of this solicitation) will result in the competitive award of a commercial, indefinite delivery, indefinite quantity, long-term, firm fixed price supply contract. This solicitation is issued under the test program at FAR 13.500, which authorizes the use of simplified acquisition procedures for commercial supplies and services up to \$5,000,000.00. This contract will include four pricing periods as set forth in paragraph 5 below. The maximum total quantity for the 4 year period will be 1,300 each for the 4 Ton Jack and 1,937 each for the 10 Ton Jack. This action is unrestricted.
2. The only guaranteed minimum quantity to be awarded under this solicitation is 400 each for the 4 Ton Jack and 471 each for the 10 Ton Jack during the first pricing period. This quantity specifically represents the "minimum quantity" as defined by and referenced in FAR and DFARS clauses contained within this solicitation document either in full text or by reference. This minimum quantity will be obligated at time of award. All other estimated buy quantities are estimates only and do not bind the government in any way.
3. Offerors are required to complete the price evaluation summary (see attachment 001 of this solicitation), for all ordering periods. Prices will be evaluated in accordance with the criteria identified in the clause FAR 52.212-2, Evaluation - Commercial Items, which is reflected in full text in this solicitation and reflected on the price evaluation summary (attachment 001). If you fail to submit prices for all quantity ranges and pricing periods, your proposal may be considered unacceptable and the government may reject your proposal. All unit prices proposed will be binding.
4. The clause at FAR 52.212-1, Instructions to Offerors - Commercial Items, identifies information which must be included with your quote. Please see attachment 004 to this solicitation for full text of this clause. Pay particular attention to paragraph (b)(4). If your technical description does not contain sufficient details to evaluate compliance with the stated requirements, your offer will be considered unacceptable. Per paragraph 1.1 Market acceptability criteria, of DFP #391 dated 14 Dec 2000: "Jacks offered under this Purchase Description shall have been in production under the same basic design for the last 3 consecutive years and shall have been sold through a customary distributor network to professional automotive maintenance customers on a competitive basis with other manufacturer's jacks of similar design and intended market niche. The supplier to the Government shall demonstrate that the offered product is supported with adequate spare parts, commercial operation and maintenance manuals, and established repair facilities based in a broad geographic pattern for national and international support with experience at servicing and repairing the specific offered product."

The ranges on the price evaluation summary (attachment 001), are provided solely for the purpose of establishing reasonable quantities against which to provide prices, and to establish ordering limitations in the event that orders beyond the guaranteed minimum quantity are executed. Also, see clause FAR 52.216-19, Order Limitation, which is in full text in this solicitation.
7. The price evaluation summary (attachment 001) will be used for evaluation purposes only. An award under this solicitation in no way obligates the government to order more than the guaranteed minimum quantity of 400 each of the 4 Ton Jack and 471 each of the 10 Ton Jack in pricing period 1. Each order stands on its own insofar as it obligates the government.
8. All prices will be proposed based on a F.O.B Origin delivery. All delivery orders will be issued unilaterally by the government with firm delivery dates and ship to address. Deliveries shall commence within 120 days after receipt of an order at a minimum rate of 100 units per month (unless the order or remaining order is less than this amount) until the order is completed.. Earlier delivery is authorized provided there is no additional cost to the government.
