This solicitation, DAAE20-02-R-0007, is issued under competitive negotiation procedures as an unrestricted buy that will result in the competitive award of a 5-year long term Fixed-Price Indefinite Delivery Indefinite Quantity (IDIQ) contract for Hose Assemblies. This contract includes 5 ordering periods as set forth in paragraph 8.

Quantity of 5,879 each Hose Assemblies, NSN: 4720-01-378-6479, is the guaranteed minimum quantity to be awarded under this solicitation and specifically represents the "Minimum Quantity" as defined by and referenced in FAR and DFARS clauses contained within this solicitation document either in full text or by reference. This minimum quantity will be obligated at time of award. All other future projected quantities are estimates only, and do not bind the Government in any way.
3. The minimum and maximum quantities, as shown below and on the Pricing and Evaluation Spreadsheet at Attachment 004 are provided solely for the purpose of establishing reasonable ranges of quantities against which to provide prices, and to establish ordering limitations in the event that orders beyond the guaranteed minimum quantity are executed.
4. Please note that this solicitation contains a "Section B", Supplies or Services and Prices/Costs", which is for item identification purposes only. The contractor shall fill in prices on the pricing page identified as Attachment 004. After contract award, each delivery order issued against the resultant contract shall contain a Section B based on the pricing page at Attachment 004.
