1. The Government will evaluate offers based on prices proposed for all CLINs for all pricing periods and any other price related factors required by the solicitation.

a. For purposes of evaluating CLINs 0001 and 0002, the Evaluated Price will be calculated by summing the multiplication of the proposed unit price by its respective weight and maximum quantity of each range for a given ordering period. The evaluated CLIN price is the sum of the evaluated prices for all pricing periods.

b. The Total Evaluated Price is the sum of the evaluated CLIN prices for each ordering period, for all items.

2. If an offeror fails to propose for all pricing periods, the Government may reject that offer as unacceptable.
