SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this modification is to add Engineering Change Proposal (ECP) L1S2116, attachment 004, and to delete from the contract the Government's requirement to provide HPT ammunition as Government Furnished Material. ECP L1S2116 was incorporated by TACOM-RI letter dated 8 Nov 2001, attachment 005.
2. Due to the unavailability of Government Furnished HPT Ammunition, ECP L1S2116 allows the contractor to use commercial HPT Ammo for testing requirements. The Government provided HPT Ammo pursuant to clause ES6043; however, this clause is hereby amended to remove this requirement (HPT Ammo) from the contract. Accordingly, the Government shall not and will not furnish any further rounds of HPT, 5.56mm for this Delivery Order.
3. The contractor proposed a total cost of \$11,157.96 (\$0.79 per round including a 10% overage) by letter dated 09 Nov 2001, attachment 006. The Government accepts the cost of \$11,157.96 (14,124 rounds x \$0.79 = \$11,157.96 for Delivery Order 0003. Thus the contractor shall be reimbursed for the purchase of 14,124 rounds of HPT Ammo at a unit price of \$0.79 per round for Delivery Order 0003.
4. As a result of this increase, Clin 0003AA is established in the amount of \$11,157.96 for 14,124 rounds of HPT Ammo. Therefore, the total contract is increased by \$11,157.96 from \$12,420,447.60 to \$12,431,605.56.
5. This modification constitutes full and final payment of any and all claims arising under or related to the changes described herein.
6. All other terms and conditions remain the same.
