SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this modification is to incorporate Value Engineering Change Proposal (VECP) L1S9043 (Attachment 001) approved with modifications on March 26, 2002. This VECP replaces the current aluminum door of the M16 Rifle buttstock with a plastic molded design.
2. As a result of acceptance of this VECP, a unit cost reduction is hereby incorporated for Line Item 0019, Door Assembly, Thumb, NSN: 1005-01-228-8504, PN: 9381380. The original awarded unit prices for Ordering Period 3 and Ordering Period 4 are decreased by \$2.64 each from \$9.16 to \$6.52 each and \$2.89 each from \$9.80 to \$6.91 each respectively. This unit cost reduction shall apply to all subsequent delivery orders awarded under this contract.
3. All other terms and conditions remain unchanged.
