SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this supplemental agreement modification P00002 is to make the following change to Contract DAAE20-02-D-0134:

A. The requirement in paragraph 1B on page 2/2 of Modification P00001 to the contract is changed from: "For the first Delivery Order only, if the order is based on an exchange of Bacharach Model A8020 FITS systems, the Government shall begin furnishing 6 systems to the contractor, which shall be shipped no later than 10 Nov 02, and continue to furnish the contractor at a rate of 3 units per month to completion, unless the order quantity or remaining quantity is less than 3, in which case the entire quantity shall be furnished," is changed to: "For the first Delivery Order only, if the order is based on an exchange of Bacharach Model A8020 FITS systems, the Government will furnish 6 systems to the contractor, which shall be shipped no later than 12 Nov 02, and 6 systems to the contractor, which shall be shipped no later than 10 Dec 02, and beginning 30 Sep 03 continue to furnish the contractor at a rate of 3 units per month to completion, unless the order quantity or remaining quantity is less than 3, in which case the entire quantity shall be furnished."

2. All other terms and conditions of the Contract DAAE20-02-D-0134 remain unchanged.

3. Acceptance of this modification comprises a complete discharge and satisfaction of each and every claim the contractor has or may have arising from the circumstances, which led to the modification to the contract. The contractor expressly accepts this modification in lieu of any other reimbursement, equitable adjustment, remedy, or relief arising out of, related to, or associated with this modification.
