Upon receiving express approval and a notice to proceed from the Government, the Contractor shall commence with the manufacture of the production quantity sets in the amount of 275 each. The Contractor shall coordinate a partial quantity with the Government POCs above and ship as a first partial shipment to be delivered on or before 2004JUN14. The Contractor shall coordinate a second quantity with the Government POC above and ship as a second and final shipment to be delivered on or before 2004JUN30. DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

SCOPE OF WORK

PERFORMANCE SPECIFICATIONS AND REQUIREMENTS

The Contractor shall manufacture and deliver Cover and Flange Set, 275 sets, in support of the Multiple Round Container Program in accordance with the specifications and drawings herein.

C.1 PART I: Covers

C.1.1 The Contractor shall manufacture and deliver 275 each Covers in support of the Multiple Round Container Program and as specified by the terms and conditions contained herein.

C.2 Objectives

C.2.1 Phase I- Fabricate four (4) covers for inspection and First Article Testing per the provided technical drawings.

C.2.2 Phase II- Upon successful completion of First Article Testing, fabricate 275 covers per technical drawings and deliver to Pine Bluff Arsenal.

C.3 Requirements

C.3.1 Configuration: Each cover must meet the dimensional, material, and surface finish requirements per the ECBC-RI technical Drawing M727007.

C.3.2 Performance: Each cover must pass First Article performance testing as designated by ECBC-RI. First Article testing will consist of 100% government inspection of those items. Inspection will occur at the contractor's facility.

Statement of Work

C4 General

C.4.1 The contractor shall furnish the necessary services, labor, personnel, facilities, supplies, materials, and equipment (including fabrication machinery and quality assurance measurement devices) to perform the following manufacturing work.

C.4.2 Specific: Phase I: Fabricate Four (4) Covers for First Article Testing.

Contractor will complete the four (4) First Article items by 2004APR30. Careful attention must be paid to achieving no greater than a 32 micro-inch finish in the o-ring contact areas of the cover. A burnishing tool is recommended to help achieve this requirement, but is not required. Upon completion, the government will conduct 100% quality dimensional and surface profile checks on First Article samples at the contractor's facility. Once government QA inspections are completed, items will be shipped to Pine Bluff Arsenal at the address listed at the end of the requirements listed in Phase II. First Article inspections will be made within 2 weeks of fabrication of the items.

C.5 Specific: Phase II: Manufacturing, Production, and Quality Assurance

C.5.1 The contractor shall, following successful First Article Test completion, commence production of 275 covers for the 7x27 MRC program according to ECBC-RI engineering drawing M727007. The government will notify the contractor within 60 days of receipt of First Article Items on the approval, conditional approval, or disapproval of first article items per the outcome of the First Article test.

C.5.2 The contractor shall serialize each cover by stamping in 1/8 inch lettering using designated serial numbers provided by ECBC-RI in accordance with drawing SN_M727_2004.

C.5.3 The contractor shall make quality inspections on 100% of items produced (at selected points) and will complete the attached government furnished inspection sheet for each item and mail to the address specified in A.5. Inspections will include both dimensional and surface roughness measurements. A government QA inspector will visit the contractor's production facility at the end of production and check a random sample of items to determine if items were
