C. Scope of Work

C.1 The Contractor shall manufacture and deliver 275 each Shipping Containers, 7"X27", in support of the Multiple Round Container (MRC) Program, and in accordance with the enclosed specifications and drawings.

C.1.1 The Contractor shall manufacture four (4) first article test samples(FATS) and 275 production quantity shipping containers in accordance with Drawing ACV00560. Hasp/swivel and hinges shown on Drawings ACV00560 are provided for the Contractor's use for reference and contractor may substitute commercial items of similar size and material, using Drawings 7896524, 8796523, and 8796520 as a guide. Note: Clause C.7 below.

C.2 A Firm Fixed Priced type contract is hereby awarded. In accordance with FAR 5.202(a)(2), a sole source award is applicable based upon urgency.

C.3 The Contractor is certified as a HUBZone Small Disadvantaged Business.

C.4 First Article Test Samples (FATS) and Report are not a separately priced item. Therefore, costs are amortized into the unit price of the production quantity.

C.4.1 First Article Testing is not a requirement to be performed by the Contractor under this award.

C.4.2 The Contractor shall manufacture and deliver the First Article Test Samples to the Government. The First Article Testing will be performed by another contractor under a separate contractual agreement.

C.5 Contractor shall make delivery as specified in Schedule B.

C.6 This is an urgent requirement.

C.7 The Contractor shall manufacture Shipping Container, 7"X27", 4 each, and ship to the Government for inspection and testing, and approval by the Government. Upon receiving express approval and a notice to proceed from the Government, the Contractor shall commence with the manufacture of the production quantity in the amount of 275 each. The Contractor shall coordinate a partial quantity with the Government POCs identified below and ship as a first partial shipment to be delivered on or before 2004JUN14. The Contractor shall coordinate a second quantity with the Government POC above and ship as a second and final shipment to be delivered on or before 2004JUN30. The Contractor may coordinate and expedite the shipments and quantities at no additional cost to the Government and with coordination with the Government POCs below.

Costs of the additional first article testing resulting from any of the causes listed herein that were instituted by the contractor and not due to changes directed by the Government shall be borne by the Contractor.

f. Rejected first articles or portions thereof not destroyed during inspection and testing will be held at the government first article test site for a period of 30 days following the date of notification of rejection, pending receipt of instructions from the Contractor for the disposition of the rejected material. The Contractor agrees that failure to furnish such instructions within said 30 day period shall constitute abandonment of said material by the Contractor and shall confer upon the Government the right to destroy or otherwise dispose of the rejected items at the discretion of the Government without liability to the Contractor by reason of such destruction or disposition.

further action required of the Contractor. A notice of disapproval shall cite reasons for the disapproval.

(c) If the first article is disapproved, the Contractor, upon Government request, shall submit an additional first article for testing. All costs related to these tests are to be borne by the Contractor, including any and all costs for additional tests following a disapproval. If first article tests reveal deviations from contract requirements, the Contractor shall, at the location designated by the Government, make the required changes or replace all items produced under this contract at no change in the contract price.

(i) The Government may waive the requirement for first article approval test where supplies identical or similar to those called for in the schedule have been previously furnished by the Offeror/Contractor and have been accepted by the Government. The Offeror/Contractor may request a waiver.

(j) The Contractor shall produce both the first article and the production quantity at the same facility.
