## SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this modification is to exercise the option for the Engineering and Logistics System Technical Services (STS), CLIN 0002, in accordance with FAR 52.217-9. The exercise of the option is based on a Cost Plus Fixed Fee (CPFF) contract.

2. The CPFF total for the option is \$346,611.00, broken out as follows:

3. The CPFF option totals 3,724 hours.

4. The Performance Period for the option extends through November 2000, for a total of 18 months.

5. The Fixed Fee of \$29,666.00 will be invoiced on a monthly basis, at \$1,648.00 per month for 17 months, and a final invoice of \$1,650.00 for the last month.

6. As a result, the contract total increases \$346,802.00, from \$628,963.00 to \$975,765.00.
