1. The purpose of this modification is to:

a. Provide funding in the amount of \$236,093.00 for Systems Technical Support (STS) for the Government of Belgium (Case BE-WDB). CLINs 0011AB and 0011AC are established for this purpose as shown below and in Sections B and G of this modification:

b. Provide additional funding in the amount of \$200,000.00 for Systems Technical Support (STS) for the Government of Jordan (Case JO-VVZ). Therefore, CLIN 0010AB will be increased by \$200,000.00 from \$151,768.00 to \$351,768.00 as shown in Sections B and G of this modification.

2. As a result of the above changes, the total amount of the contract is increased by \$436,093.00 from \$14,300,264.18 to \$14,736,357.18.

3. All other terms and conditions remain unchanged.
