SECTION A - SUPPLEMENTAL INFORMATION

The purpose of this modification is to incorporate the following provision into the Scope of Work for the basic contract.:

2.1.2.1 Employee Qualifications Certification. Substitution of education for experience may be made for employees in the labor categories of Systems Analyst, Programmer/Analyst, Programmer, Computer Equipment Specialist, Tech Writer/Editor, Data Base Administrator, Clerical Data Input Clerk, Computer Software Integration Analyst I, and Junior Programmer. Education shall be in a related field such as Information Management or Computer Science. Education may be a degree, diploma, certificate, or other training sufficient to demonstrate the necessary knowledge or skill required to perform on the assigned Task Order. Education may not necessarily be a direct year-for year substitution for experience, but shall be sufficient to reasonably indicate qualifications to perform in a satisfactory manner. Should the contractor elect to substitute education for experience, the requirement for Personnel Resume described in paragraph 2.1.2 above will be waived and replaced with completion of an Employee Qualification Certification which is to be signed by an officer of the firm. The format for the Employee Qualification Certification is that as shown as an attachment herein. Substitution of education for experience for labor categories not listed earlier in this paragraph may be submitted for contracting officer consideration and approval/disapproval.

All other terms and conditions remain unchanged.
