SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this modification is to exercise the option clause, FAR 52.217-9. As a result, the terms and conditions of the contract are extended an additional 18 months from the effective date of this modification. NOTE: This modification represents the exercise of the first 18 month option period, with one additional 18 month option period available.

2. The evaluated option provision obligates an additional \$297,925.00 on a Cost-Plus Fixed Fee basis, as follows:

Estimated Cost	\$272,441.00
Fixed Fee	25,484.00
Total	\$297,925.00

3. The contractor is authorized to invoice the Government for reasonable costs incurred in performance of the contract on a monthly basis. For billing purposes, the contractor is authorized to invoice the Fee at a rate of 9.5%, based on allowable costs incurred per month. The total Fee amount invoiced will not exceed \$25,484.00 for the 18 month performance period. If the total Fee amount has not been invoiced by the end of the performance period, the contractor will submit a final invoice for the remaining Fee.

4. The contract total is increased \$297,925.00, from \$484,770.00 to \$782,695.00.

5. All other terms and conditions of the contract remain unchanged.
