PACKING LEVEL B IS REQUIRED AND SHALL BE IN ACCORDANCE WITH MIL-STD-2073-1, REVISION C, DATED 1 OCT 96. MARKING SHALL BE IN ACCORDANCE WITH MIL-STD-129, "STANDARD PRACTICE FOR MILITARY MARKING", REVISION N DATED 15 MAY 97. BAR CODING REQUIREMENTS APPLY. UNIT PACKAGES SHALL BE CLOSED PER METHOD 2B7 OF ASTM D 1974.

EXCEPTIONS: SEALING METHOD B FOR USE WITH 2" WIDE PRESSURE SENSITIVE TAPE CAN BE USED FOR CLOSURE OF THE UNIT PACK. THE UNIT PACKAGES SHALL BE PLACED IN AN APPROPRIATE SIZE SHIPPING CONTAINER (MAXIMUM OF 24 UNIT PACKAGES PER SHIPPING CONTAINER) CONFORMING TO ASTM D 5118, STYLE RSC, GRADE V3C, CLASS WEATHER RESISITANT AND SEALED IN ACCORDANCE WITH ASTM 1974, SEAL METHOD B OR C.

PALLETIZATION: SHIPMENTS OF IDENTICAL ITEMS GOING TO THE SAME DESTINATION SHALL BE PALLETIZED IF THEY HAVE A CUBIC DISPLACEMENT OF 50 CUBIC FEET OR MORE UNLESS SKIDS OR OTHER FORKLIFT HANDLING FEATURES ARE INCLUDED ON THE CONTAINERS. PALLET LOADS MUST BE STABLE, AND TO THE GREATEST EXTENT POSSIBLE, PROVIDE A LEVEL TOP FOR EASE OF STACKING. A PALLETIZED LOAD SHALL NOT EXCEED 4,000 POUNDS AND SHOULD NOT EXCEED 49 INCHES IN LENGTH, 41 INCHES IN WIDTH OR 54 INCHES IN HEIGHT. THE LOAD SHALL BE CONTAINED IN A MANNER THAT WILL PERMIT SAFE HANDLING DURING SHIPMENT AND STORAGE.
