SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this modification is as follows:

a. To clarify the time frames for the 3 ordering periods and 2 option years of this long term contract. These time frames are as follows:

Ordering Period 1: 20 May 98 - 30 Sep 98
Ordering Period 2: 01 Oct 98 - 30 Sep 99
Ordering Period 3: 01 Oct 99 - 30 Sep 00
Option Year 1: 01 Oct 00 - 30 Sep 01
Option Year 2: 01 Oct 01 - 30 Sep 02

b. To revise the last sentence in paragraph (a) of FAR Clause 52.216-18, entitled, "Ordering". (This clause can be found on page 37 of the solicitation portion of the contract.) This revision is as follows:

FROM: Such orders may be issued from date of award through 01 Mar 2000.
TO: Such orders may be issued from date of award through 30 Sep 2002.

c. To revise paragraphs (a) and (b)(1) of FAR Clause 52.216-19, entitled "Order Limitations". (This clause can be found on page 37 of the solicitation portion of the contract.) This revision is as follows:

FROM: (a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than 2500 per month unless the parties negotiate otherwise,

(b)(1) Any order for a single item in excess of 2500 unless the parties negotiate otherwise;

TO: (a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than 200 per month unless the parties negotiate otherwise;

(b)(1) Any order for a single item in excess of 5,000 unless the parties negotiate otherwise;

d. To revise the last sentence in paragraph (f) of FAR Clause 52.216-21, entitled "Requirements". (This clause can be found on page 37 of the solicitation portion of the contract.) This revision is as follows:

FROM: that the Contractor shall not be required to make any deliveries under this contract after September 30, 2000 for the basic contract period or as changed by the option clause.

TO: that the Contractor shall not be required to make any deliveries under this contract outside the time specified within each individual delivery order.

e. To revise, for clarification purposes, paragraphs (b) and (c) of DFAR Clause 52.217-4002, entitled "Options for Additional Quantities" (This clause can be found on page 54 of the solicitation portion of the contract.) This revision is as follows:

- (1) In paragraph (b), replace the number 1,050 with the date April 10, 2001.
- (2) In paragraph (c), replace the number 1,410 with the date March 29, 2002.

f. To incorporate the following statement for the purpose of clarification:

The delivery schedule for each delivery order, will be negotiated on an individual basis.
