SECTION A - SUPPLEMENTAL INFORMATION

1. The purpose of this no-cost modification, based on a PEI Electronics Inc. request, amends this Basic Ordering Agreement (BOA) by adding the following referenced FAR clauses:

- c) DFARS 252.228-7000 REIMBURSEMENT FOR WAR HAZARD LOSSES, located in clause table I-13.
- d) DFARS 252.228-7003 CAPTURE AND DETENTION, located in clause table I-13.
- e) DFARS 252.225-7043 ANTITERRORISM/FORCE PROTECTION POLICY FOR DEFENSE CONTRACTORS OUTSIDE THE UNITED STATES, located in clause table I-13.
- f) DFARS 252.209-7001 DISCLOSURE OF OWNERSHIP OR CONTROL BY THE GOVERNMENT OF A TERRORIST COUNTRY, located in clause table I-13.

The above referenced clauses are required in all contracts and delivery orders when the deployment of contractors are anticipated. The clause reference table I-13 established by this modification will apply to subsequent Delivery Orders and Delivery Order modifications that require the deployment of contractors during contingency operations.

Any contingency operation support directed by the Government under this Basic Ordering Agreement (BOA) will be governed by an appropriate Scope Of Work that supports rapid deployment of contractor personnel to the Theatre of Operations.

2. This change is effective on the date of PCO signature approving this modification.

3. All other terms and conditions remain unchanged.
