4. TO CLARIFY AMSTA-LC-CAC-A LETTER DATED 03 JUL 2001 WHICH CHANGED THE REPAIR STATUS OF THE DECU. THE LETTER SHOULD HAVE STATED THAT REPAIRS ARE TO BE LIMITED TO MINOR REPAIRS AND REPLACING SRU'S. MAJOR REPAIRS ARE TO BE DONE BY HONEYWELL, UTILIZING THE GOVERNMENT'S CONTRACT WITH HONEYWELL. THESE ITEMS ARE TO BE SCREENED AND STORED AT THE TAP FACILITY. THOSE ITEMS NEEDING MAJOR REPAIR WILL BE STORED AT THE TAP FACILITY UNTIL A GOVERNMENT ITEM MANAGER DIRECTS SHIPMENT TO HONEYWELL.

5. TO CLARIFY THE FUNDING ON CLIN 0008AV, PWD 471BCM0547. IN ADDITION TO FUNDING M1A1D BCIS KITS, THE PURCHASE OF THE RECONFIGURATION AND EXPANSION OF THE PARTS TECHNICAL INSPECTION AREA IS AUTHORIZED UNDER CLIN 0008AV. THE PURCHASE OF ADDITIONAL EQUIPMENT FOR USE IN THE TAP FACILITY IS AUTHORIZED UNDER CLIN 0008AV. THE LIST OF AUTHORIZED EQUIPMENT IS AT ATTACHMENT 02. THIS EQUIPMENT WILL BE ADDED TO THE LIST OF GOVERNMENT FURNISHED EQUIPMENT. THERE IS NO CHANGE IN THE TOTAL DOLLAR AMOUNT ON THE CONTRACT AS A RESULT OF THIS ACTION.
